Trade union Solidarity on 12 July 2016 said it would do everything in its power to prevent possible retrenchments at Sibanye, Westonaria. This comes in the wake of reports that around 2 500 jobs at the company's Cook 4 mine are in jeopardy.

In its report on retrenchments issued earlier this year, Solidarity indicated that approximately 30 000 jobs in the mining industry have come under threat during the past year. That being the case Solidarity would pull out all the stops to prevent more jobs being affected in the industry.

"Solidarity already had a very positive informal discussion with the Sibanye management, during which both parties committed themselves to a process to investigate all possible alternatives to prevent forced retrenchments," Solidarity General Secretary Gideon du Plessis said.

"During our discussion with the Sibanye management it came to our attention that many vacancies exist within the Sibanye Group. We will therefore encourage our members working at Cooke 4 to immediately accept any transfers to another Sibanye mine or shaft, thereby ensuring job security," Du
